

PARENTAL CONSENT

We further, jointly and severally, state the following:

1. We are satisfied that the foregoing Terms and Conditions is fair and equitable. We state that our Child/my Child and that we on behalf of our Child/my Child have understood and accept all the provisions of the Terms and Conditions. We hereby give our irrevocable, unconditional, express, consent to and undertake to ensure the execution and fulfillment of the said Terms and Conditions by our Child/my Child as stated above and shall not revoke our consent at any time.
2. We hereby undertake that our Child/myChild’s participation in the Auditions/ Program is free of any undue influence or coercion, and is with our express consent. We hereby further agree and undertake that all necessary and required documents under the laws governing our jurisdiction will be furnished to the Company as per the timelines and requirements of the Company, and we hereby further undertake and confirm that we shall furnish or execute any and all necessary documents as may be required by the Company pursuant to the applicable laws in our jurisdiction.

3. We hereby agree and undertake that our Child's/myChild's participation in the Auditions/ Program is not prohibited or restricted under the applicable laws in our jurisdiction.
4. We hereby fully and unconditionally guarantee the performance of our Child's/Child's obligations including our obligations as the parents/ legal guardian as set forth in the Terms and Conditions.
5. We unconditionally guarantee and shall ensure the full and timely performance by our child/ward's of all his/her participation, obligations, duties and warranties owed towards the Program, Auditions, Company and its successors and assigns.

We undertake to, jointly and severally, indemnify the Company and keep its successors assigns and licenses at all times fully indemnified from and against all actions proceedings claims demands costs (including but not limited to legal costs) awards and damages arising directly or indirectly as a result of any breach or non-performance by our child/ward of any her/his undertakings, representation and warranties and obligations as stated in the Terms and Conditions or any breach of our obligations as stipulated in this consent form or the Terms and Conditions.
